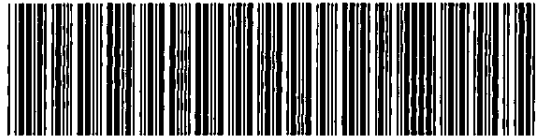

**ARTICLES OF INCORPORATION  
OF  
YOUTH SAILING FOUNDATION OF INDIAN RIVER COUNTY, INC.  
A Florida Corporation Not-For-Profit**

The undersigned, for the purpose of forming a Not-for-Profit Corporation under Florida General Corporation Act, hereby adopts the following articles of incorporation:

**ARTICLE I**

The name of this Not-for-Profit Corporation shall be Youth Sailing Foundation of Indian River County, Inc., hereinafter referred to as the "Foundation."

**ARTICLE II**

The initial street address of the principal office of this Foundation in the State of Florida is 2305 46th Avenue, Vero Beach, Florida 32966. Meetings of members and of the Board of Directors may be held at such place within the State of Florida as may be designated by the Board of Directors.

**ARTICLE III**

This Foundation may engage in any activity or business permitted under the laws of the United States and the State of Florida. The purposes for which the Foundation is organized are as follows:

1. To operate as a corporation not-for-profit pursuant to the Florida Statutes.
2. To have and to exercise any and all powers, rights and privileges which a corporation organized under the not-for-profit corporation statutes of the State of Florida by law may now or hereafter have or exercise
3. To promote the sport of sailing for the benefit of the young people of Indian River County in an atmosphere which stresses safety, good sportsmanship, honesty, loyalty, courage, respect for authority, appreciation of the environment, and respect for the community.

#### **ARTICLE IV**

Any person sincerely interested in furthering the objectives of the Foundation may apply to become a member. The Board of Directors, at its option, may review membership applications and vote to accept or deny an application, or designate a person or committee to review and approve the applications in its stead.

#### **ARTICLE V**

The affairs of the Foundation shall be governed by a Board of Directors, consisting of the number of directors as determined by the by-laws, but not less than three (3) directors, and can consist of up to nine (9) directors. All Directors shall enjoy equal voting rights.

The Board shall elect a Vice-Chairman from among the Directors and shall select Members of the Foundation as Treasurer and as Secretary. As determined by the Board, other offices may be created.
