ARTICLES OF INCORPORATION

Iglesia Bautista Internacional del Sur de la Florida, Inc.

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: NAME.

The name of the corporation shall be Iglesia Bautista Internacional del Sur de la Florida, Inc.

ARTICLE II: PRINCIPAL OFFICE.

The principal street address and mailing address, if different is 4449 Sago Circle, Weston, Florida 33331.

ARTICLE III: PURPOSE.

- 1. Iglesia Bautista Internacional del Sur de la Florida, Inc. is a family of faith that exists to be and to make disciples of Jesus Christ, and to extend His Kingdom in our community and to the ends of the Earth.
- 2. This corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV: POWERS.

- 1. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, advisory board, committees, council, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof.
- 2. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- 3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V: DISSOLUTION.

1. In the event of the dissolution of liquidation of this corporation, to the extent allowed or permitted under applicable laws, after paying or making provisions for the payment of all liabilities of the corporation, the trustees shall dispose of all assets to a not for profit 501(c)(3) organization exclusively for the purposes of the corporation in such a manner, to operate exclusively for religious purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding provision of any future United States

Internal Revenue laws, as the Board of Directors shall determine. Assets may only be distributed to the Gulf Stream Baptist Association.

2. However, if the named recipient is not then in existence or no longer a qualified distribute, or unwilling or unable to accept the distribution, then the assets of this corporation/organization shall be distributed to the Florida Baptist Convention.

ARTICLE IV: MANNER OF ELECTION.

- 1. All subsequent officers and directors must be members of the Iglesia Bautista Internacional del Sur de la Florida, Inc. Their election shall take place at a meeting called for that purpose of which at least one week's public notice has been given. An affirmative vote of three-fourths of those members present will validate the choice. The officers and directors shall be replaced or elected for a new term at the annual election of officers of the Iglesia Bautista Internacional del Sur de la Florida, Inc.
- 2. Officers may not be related to any other officer, nor can officers be related to the Pastor. All Officers of the corporation must be citizens of or reside legally within the United States of America.
- 3. The initial officers and directors shall be appointed by the Pastor, upon procuring verbal agreement by the prospective officer. The Pastor may not be related to or employed by any of the initial officers and directors. In addition, none of the initial officers may be related to or employed by another initial officer. The initial officers and directors will serve for a term not to exceed two years.
