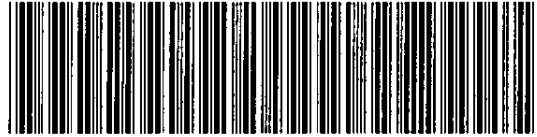

## ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit) 09 SEP 24 PM 3:47

### ARTICLE I NAME

The name of the corporation shall be: **SON OF THE EAGLE FOUNDATION INTERNATIONAL, INC.**

### ARTICLE II PRINCIPAL OFFICE

The principal street address and mailing address is: **6959 Torres Dr, Jacksonville, FL 32210**

### ARTICLE III PURPOSE

The purposes for which the corporation is organized are:

#### Primary Purpose

To be established as a public charity to provide material and financial assistance, as well as non-material support, edification, and encouragement, to the poorest of the poor or the most needy among deserving church pastors, evangelists, church planters, missionaries, and other workers in Christian ministry around the world.

#### Secondary Purposes

1. To invest in or enter into money-making transactions or ventures and to engage in fund-raising activities, as well as accept donations and gifts, solely for purpose and benefit of organization.
2. To determine, on its own or with the aid of other persons, who should be the beneficiaries of the Foundation's assistance, support, edification, and encouragement.

### ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed shall be governed by the provisions of the By-laws of the corporation.

The corporation shall be a sovereign body, and the regulation of the internal affairs of the corporation shall be governed by the provisions of the By-laws of the corporation.

#### **ARTICLE VI**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE VII**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


