Article III of the Articles of Incorporation is hereby amended to read as follows:

This corporation is a not for profit corporation. The purpose for which the corporation is
organized is to create awareness, and perform research and treatment of prostate cancer
within the meaning of section 501(c)(3). This corporation is formed to operate
exclusively for charitable, educational, and scientific purposes under section 501(c)(3) of
the Internal Revenue Code, or corresponding section of any future federal tax code.

Article VII is hereby added to the Articles of Incorporation to read as follows:

Upon the dissolution of this corporation, assets shall be distributed for one or more
exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or
corresponding section of any future federal tax code, or shall be distributed to the federal
government, or to a state or local government, for a public purpose.


