# ARTICLE VI CESSATION PLAN

In the event Corporation shall dissolve, cease to exist, or depart from the polity of the Church of God, as expressed in the *Church of God General Assembly Minutes*, as now written or may hereafter be written, the assets of the corporation shall revert to the State Trustees for the Church of God in the state of Florida, or to one or more organizations described in Section 501 (C)(3) of the Internal Revenue Code (U.S.A.) or the corresponding sections of any prior or future Internal Revenue Code (U.S.A.).

# ARTICLE VII INITIAL REGISTERED AGENT AND STREET ADDRESS
