4. Manner of Election:

Section 1) Annually, or whenever a board director resigns, vote ballots will be cast out amongst all members who do not hold a position on the board of directors. This group of members will evaluate and vote on each director's performance level and state whether the director should hold a position on the board the proceeding year.

Section 2) In the case that a director receives a vote from all those who voted of 50% or more in favor of their stepping down from the board, a meeting will be held amongst the voters to nominate 2 members to potentially replace the director. Follow to "Section 4".

Section 3) In the case that a director receives a vote from all those who voted of 75% or more in favor of their stepping down from the board, the director will immediately leave his/her position on the board. A meeting will then be held amongst the voters to nominate 3 members to potentially replace the director. Follow to "Section 5".

Section 4) Following "Section 2", a meeting will be held with the board of directors, excluding the director in jeopardy of being replaced, to interview one by one the 2 nominees and the previous director. After review, the board of directors, again excluding the director in jeopardy of being replaced, will vote on who will be the member to fill the vacant director position.

Section 5) Following "Section 3", a meeting will be held with the board of directors to interview one by one the 3 nominees. After review, the board of directors will vote on who will be the member to fill the vacant director position.
