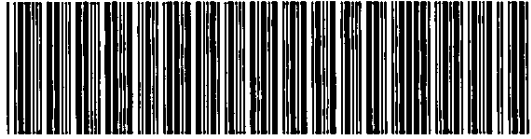



Pursuant to the provisions of section §617.1006, Florida Statutes, this Florida Not-For-Profit Corporation adopts the following amendment to its Articles of Incorporation:

- 1. Article IX is added as follows:

“ARTICLE IX

Upon dissolution of the company, all remaining company assets shall be distributed outright to one or more 501(c)(3) tax exempt organizations.”

- 2. The foregoing amendment was adopted by the unanimous consent of all of the directors of the Company on September 11, 2015. Members are not entitled to vote.
