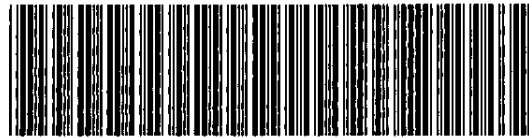

ARTICLE 3 (CHANGE) THE SPECIFIC PURPOSE FOR WHICH THIS CORPORATION IS ORGANIZED IS :

The Corporation is organized exclusively for charitable , religious , educational , and scientific purposes , including , for such purposes , the making of distributions to organizations qualify as exempt organizations under 501 (c) 3 of the internal revenue code or corresponding section of any future federal code.

ARTICLE 4 (CHANGE) THE MANNER IN WHICH DIRECTORS ARE APPOINTED OR ELECTED

Directors are elected for two (2) years.

ARTICLE 5 AND 6 (SEE ADDITIONAL PAPERS INCLUDED)

ARTICLE 5 , 6 , 7 BECOME ARTICLE 7 , 8 , 9

ARTICLE 5.-

No part of the Earnings of the organization shall inure to benefit of , or be distributable to its members, trustees , officers , or other private persons , except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part fo the activities of the organization shall be carrying on of propaganda , or otherwise attempting to influence legislation , and the organization shall not anticipate in , or intervene in , (including the publishing and distribution of statements) any political campain on behalf of any candidate for public office. Notwithstanding any other provision of this document , the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) 3 of the Internal Revenue Code , or corresponding section of any future federal code , or (b) by an organization , contributions to which are deductible , under section 170 (c) (2) of the Internal Revenue Code , or corresponding section of any future federal code.

ARTICLE 6.-

Upon the Dissolution of the organization , assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) 3 of the Internal Revenue Code , or Corresponding section of any future federal code ,or shall be distributed to the Federal Government , or to a state , or local government , for a public purpose. Any such assets not disposed of shall be disposed by the Court of Common Pleas of the County in which the principal office of the organization , as said Court Shall determine , which are organized and operated exclusively for such purposes.
