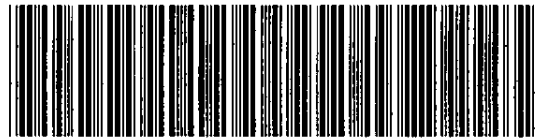

ARTICLE III: Providing and environment for women and girls with monitoring programs, government assistance, housing assistance, career development and training, college preparation, and mostly importantly helping women and girls recognize their self worth. Any such assets not disposed of shall disposed of the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
