*ARTICLE ONE*

The name of the Corporation is CHURCH OF SOUL RESTORATION "TIKUM", INC.

*ARTICLE TWO*

The Corporation is non-profit organization.

*ARTICLE THREE*

The period of duration is perpetual

*ARTICLE FOUR*

*The Corporation is organized exclusively for charitable, spiritual, literary, cultural, educational, or scientific purposes, including, for such purposes, the making of distributions either directly or by contributions to organizations that qualify as exempt organization within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future United States Internal Revenue law.*

#### *ARTICLE EIGHT*

Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding provisions of any future Federal Tax Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code.

#### *ARTICLE NINE*

Neither the member(s) nor the member(s) of the Board of Directors or Officers of the Corporation shall be liable for the debts of the Corporation. The method of election of directors is as stated in the bylaws

#### *ARTICLE TEN*

Resolved that any salaries, wages, together with fringe benefits or other forms of compensation (housing, transportation and other allowances) paid to or provided to our employees, directors, or officers will not exceed a value which is reasonable and commensurate with the duties and working hours associated with such employment and with the compensation ordinarily paid persons with similar positions or duties.

#### *ARTICLE ELEVEN*

Upon Dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principle office of the Corporation is then located; exclusively for such purposes or to such organization(s), as said Court shall determine which are organized and operated for such purposes.

#### *ARTICLE TWELVE*

These Articles of Incorporation may be amended in the manner provided by statute or in the manner stated in the bylaws.


## ARTICLE FIVE
