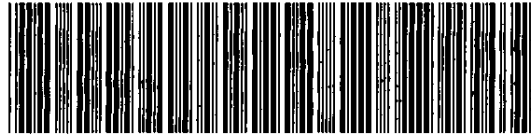

Anderson-Leger Cremations & Complete Funeral Services Inc. Is designated exclusively for Religious, Charitable, Scientific, Educational, Health, Social and Economic Development purposes; within the meaning of Section 501(C) (3) of the Internal Revenue code of 1986, as amended.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of incorporation:

Cemeteries and entitlement to Veterans benefits will also enlighten the spouses and dependent children of veterans as to their entitlement to cemetery spaces and headstones free of charge at any Veterans Cemetery. Our services will typically save a veteran family 50% of the cost associated with burial through combined benevolent collaborations. *UNCLE ARTHUR'S Veterans Community Service* was founded to help Veterans and their families. Our staff is trained to answer questions about military protocol, assure that legal requirements are met and provide whatever equipment, facilities, and technical services that may be needed. The mission of the *UNCLE ARTHUR'S Veterans Community Service* is to reduce funeral costs for veterans and their families. In addition, we will offer packages to all service connected military personnel. We handle all details. We apply for all benefits, file for Life Insurance and arrange all military honors. We have a serious responsibility to our clients.

Anderson-Leger Cremations & Complete Funeral Services Inc Will stay connected to the community through the *A.M.O.S. PROGRAM*; a charity that Aides and Assist Mothers, Offspring and Siblings. Providing help for the hurting due to sudden loss in death without adequate or any insurance, burial funds, or ability to pay on the part of the grieving families. We recognize in today's economic climate that people have less than the resources needed to live comfortable or stable lives. On site grief counseling is provided as well as conference rooms where families can meet and discuss funeral arrangements with the assistance of trained staff personnel. Families may also use the facility for assembling for the funeral procession and repast.

THE R.I.I.A. PROGRAM: or *RESTING INFANTS IN ASSURANCE* is one of our most celebrated charity programs. The loss of any loved one is heartbreaking but the loss of an infant can be devastating to parents, siblings and connected family members. Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of incorporation:

Article V: Registered Agent and Registered Office

Article VI: Indemnification and Limitation of Liability:

1. The Corporation shall indemnify any officer or President or any former officer of the corporation, fully permitted by law. The private property of the member or officer, or president shall not unless otherwise provided by law, be subject to the payment of the corporate debts to any extent whatsoever.
2. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its member, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.
3. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
4. The corporation will not carry on or perform any activities not permitted to be carried on, (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue code, or the corresponding section of any future federal tax code; or (b) by a corporation, to which contributions are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
5. This Corporation shall not discriminate in its delivery of services based on Race, Creed, Ethnicity, Culture, Sexual orientation, Financial or Economic Class or religious background or beliefs.

Article VII: Dissolution and Division of Assets

Upon the dissolution of the corporation, assets will be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or to other non-profit corporations for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organizations, as the court shall determine, which are organized and operated exclusively for non-profit purposes.

Article VII: Manner of Election

Appointment of Officers: The President appoints Members of the Board of Directors and determines the number of directors that shall sit on the Board. Vacancies arising due to a terminating event shall remain unfilled until the next annual meeting with duties assumed by other members.

Term of Office: No maximum tenure for any one office on the Board of Directors exists.

Removal from office: The President may remove a member of the Board of Directors for just cause.

Article VIII: Membership

The membership shall be open to all who support the charity ANDERSON-LEGER CREMATIONS & COMPLETE FUNERAL SERVICES Inc. Membership is on a voluntary basis with no fees attached.

Article IX: Officers

The officers of the Corporation shall consist of the following: Chair of the Board of Directors, Executive Director, Secretary, Treasurer and such other officers as the President of the Board of Directors may designate from time to time.

Article X: Duration of Existence

This corporation shall exist as a perpetual entity unless designated otherwise by the President of the corporation. The corporation is organized on a non-stock basis and shall be considered established and in existence as of the date of the prepared filing and is specified effective five (5) days prior to receipt by the office of Corporations.

Article XI: Amendments

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the members, partners or officers are subject to this reservation.

Article XII: Bylaws

This Corporation shall abide by the operating guidelines provided by the bylaws adopted by the corporation. The Bylaws may be altered, amended or repealed by President/Founder, The Board of Directors may amend or repeal any bylaws as directed by the President Founder or votes made by the board.


