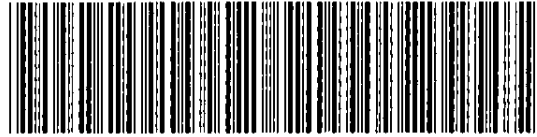

#### **Article I. Name**

Section 01      *Name:* The name of this corporation shall be "The Beta Nu Alumni Group, Inc."

#### **Article II. Registered Agent / Principal Office**

Section 01      *Registered Office and Agent:* The Beta nu Alumni Group, Inc.'s registered agent and mailing address shall be Mr. Daryl D. Parks at Parks & Crump, LLC, 240 N. Magnolia Drive, Tallahassee, Florida 32301.

Section 02      *Place of Business:* The principal place of business for the Beta Nu Alumni Group, Inc. shall be 8269 Sierra Woods Drive in the City of Tallahassee, Leon County within the State of Florida 32311.

#### **Article III. Mission**

Section 01      *Mission:* The Beta Nu Alumni Group, Inc. is organized exclusively for charitable, scholastic and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. To this end, the corporation shall bestow monetary awards on students at Florida Agricultural and Mechanical University for educational and scholastic achievement.
