SECRETARY OF STATE

The Corporation is organized and shall be operated on a not-for-profit basis and exclusively for social welfare within the meaning of Section 501 (c) (4) of the Internal Revenue Code (or the corresponding provisions of any future United States federal tax law). The specific purposes of this corporation are donating money into a Trust which will be used to help only JetBlue pilots who are experiencing a crisis which is affecting them financially. The Blue Pilot Fund, through its administration and operation, will assess and possibly mitigate a pilot's crisis through fund award distributions.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf on any candidate for public office.
