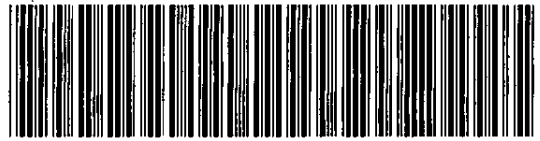


**Articles of Incorporation  
For

*ONE:* The name and address of this principal corporation is Rising Angels Daycare and Resource Center, Inc. at 104 Carlisle Ct, Kissimmee, FL 34758, in Osceola County. The Corporation is organized pursuant to the FLORIDA Non-profit Corporation Code.

*TWO:* The purpose or purposes for which the corporation is formed are as follows: to provide education and quality care to all children while providing encouragement and resources to parents to enhance their quality of life. The programs will consist of: Daycare, Food Assistance, Counseling, the distribution of Books and Toys to Poor Children, to provide Educational and Vocational Resources and referral services to aid those in need

*THREE:* The duration of this Corporation shall be perpetual, with no stock and shall have no members.



- (3) Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local organization, for public purposes.
