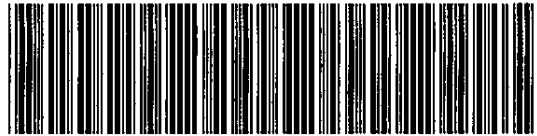

ARTICLES OF AMENDMENT
OF
BLACK PEARL PIPES & DRUMS, INC.

In compliance with the requirements of section 617.1006, Florida Statutes, Black Pearl Pipes & Drums, Inc., adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE X- DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government. for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Adoption: This Amendment was adopted on March 30, 2010.

Adoption of Amendment: There are no members or members entitled to vote on the Amendment. This Amendment was adopted by the Board of Directors.
