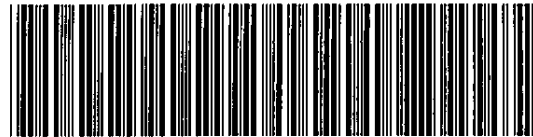

The undersigned acting as incorporators of a corporation pursuant to Florida Corporation Law Statute 617, adopts the following Articles of incorporation.

ARTICLE I
NAME

The name of the corporation shall be:

CBK&N ASSISTED LIVING, INC.

ARTICLE II
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

739 Lynton Street
Jacksonville, Florida 32208

ARTICLE III
PURPOSES

1. To operate and assisted living facility for the disabled, homeless, persons in recovery and those in need of transition housing with concentration upon the socially and economically disadvantaged.
2. To operate exclusively for charitable, religious, and educational purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provosion of any future United States Internal Revenue Law.

3. To operate as a community referral outreach organization servicing the needs of the socially and economically deprived.

ARTICLE IV DISSOLUTION

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors assets of the corporation shall be distributed to a non-profit 501 (c) (3) corporation. "However" if the named recipient is not in existence as a distributee, or unwilling to accept the distribution, the assets shall be distributed to a fund, or foundation, or organization which is operates exclusively for purposes specified in section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.

ARTICLE V LIMITATION OF POWERS

Not withstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization Exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future Internal Revenue Law.



