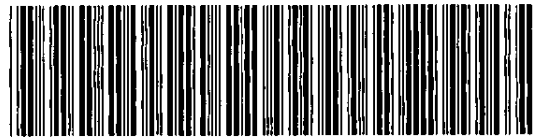

Dear Dr. Braxton:

The undersigned is General Counsel to Tutor Time Learning Centers, LLC. Our company has recently been made aware that you are using the name "Tutor Time" in the operation of two child care facilities, one center based at 5505 Normandy Boulevard, Jacksonville FL 32205 and a home based facility at 3604 Morning Meadows Lane, Orange Park FL 32073. Tutor Time Learning Centers, LLC holds the registered rights to the name and trademark "Tutor Time"-Serial Number 76112799 Registration Number-2500116. We have held these rights since 2001 and our predecessor in interest held those rights from 1990 until 2001. Furthermore, Tutor Time has operated under that name in the State of Florida since 1990 and we have operated four schools under that name in the Jacksonville area since 2001. Your use of our registered and trademarked name is unlawful and a violation of state and federal laws.

WE DEMAND THAT YOU IMMEDIATELY CEASE AND DESIST ALL INFRINGING USE OF THE NAME AND MARK "TUTOR TIME" AND REMOVE ALL SUCH MARKS FROM YOUR BUSINESSES. If you do not immediately cease and desist such use, Tutor Time Learning Centers, LLC will take all available action, including enforcement of its federally protected trademark rights.
