Baviello, Jr. is hereby appointed and shall serve as Secretary for the corporation for the express purpose of winding up and liquidating the corporation's business and affairs;

RESOLVED, that, the Board of Directors recommended and the Shareholders approved that Michael A. Baviello, Jr. is hereby appointed and shall serve as authorized agent for the express purpose of winding up and liquidating the corporation's business and affairs;

RESOLVED, that, the Board of Directors recommended and the Members approved that Michael A. Baviello, Jr., as sole Director ("Director") of the corporation be, and hereby is, authorized after payment, or provision for payment, of all debts and liabilities of the Corporation, to distribute all remaining assets of the corporation to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax-exempt status under Section 501(c)(3) of the Code or corresponding provisions of any subsequent federal tax law, as selected by the Board of Directors;

RESOLVED, that, the Board of Directors recommended and the Members approved that the corporation keep the existing account(s) at MidFlorida Credit Union (f/k/a First American Bank) for the express purpose of winding up and liquidating the corporation's

business and affairs;

RESOLVED, that, the Board of Directors recommended and the Members approved that the Corporation's accounting and bookkeeping, and that all checks to be signed by Michael A. Baviello, Jr., and that Michael A. Baviello, Jr., shall remain the custodian of all the books and records of the Corporation;

RESOLVED, that, the Board of Directors recommended and the Members approved that the Director of the corporation be, and they hereby are, authorized and directed to pay all fees and taxes and to do or cause to be done all acts and things they may deem necessary or proper in order to carry out the liquidation and dissolution of the corporation and to fully effectuate the purposes of the foregoing resolutions:

RESOLVED, that, the Board of Director recommended and the Members approved that the Director of the corporation be, and they hereby are, authorized and directed the Corporation to deliver, or cause to be delivered, to Living Water Teaching Ministries, a Section 501(c)(3) corporation, of Caddo Mills, TX, any and all remaining kitchen equipment assets of the corporation, and to do or cause to be done all acts and things the Director may deem necessary or proper in order to carry out the liquidation and dissolution of the corporation and to fully effectuate the purposes of the foregoing resolutions;
