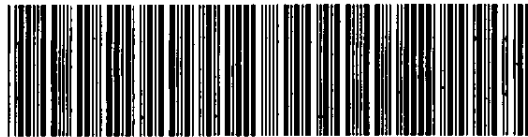

ARTICLE I - NAME

The name of this corporation shall be : Shekinah Haitian Ministries, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation is not for profit corporation, organized specifically, and primarily to solicit, collect, accumulate, administer, receive and maintain real and personal property, or both, in whatever form, including cash funds from public and private sources, and subject to the restrictions and limitations hereinafter set forth: to use and apply the whole or any part of the income there from, and the principal thereof, exclusively for religious, charitable, or religious education purposes either directly or by contributions to organizations that qualify as exempt organizations under section 501(c)(3) of the internal revenue code and Regulations issue pursuant there to as they now exist or as they may hereafter be amended.

- The real purpose for which "Shekinah Haitian Ministries, Inc" come into existence is to operate exclusively for such religious, charitable and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent Federal Tax Laws, including the making of distributions to organizations which qualify as Tax-Exempt Organizations under that Code.
- This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene by publication or distribution of any statements or otherwise, in any political campaign on behalf of any candidate for public office.

ARTICLE X - PROPERTY

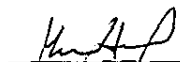

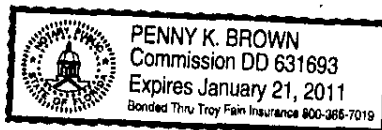
