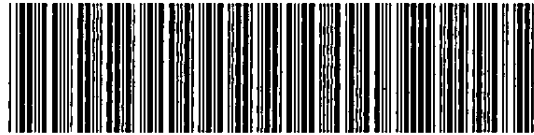

## ARTICLES OF INCORPORATION

OF

Freedom Fighters Enternational, INC.  
A Florida Not for Profit Corporation

The undersigned, acting as incorporator of a not-for-profit corporation pursuant to Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation:

### ARTICLE I – NAME

The name of this corporation is Freedom Fighters Enternational, INC

### ARTICLE II – INITIAL PRINCIPAL OFFICE

The address of the initial principal office of the corporation in the State of Florida is 7203 E. 11<sup>th</sup> St, Panama City, Fla 32404.

### ARTICLE III – PURPOSE

This is a not-for-profit corporation organized exclusively for public charitable purposes under Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Specifically, this not-for-profit corporation is organized to improve the quality of life and provide assistance to those in need. Services will be rendered in the United States as well as foreign countries.

### ARTICLE IV – BOARD OF DIRECTORS

The affairs of the corporation shall be managed by a Board of Directors, which shall consist of not less than three (3) and not more than nine (9) members of natural persons. The number, tenure of office, manner of election, and filling of vacancies shall

be as provided in the Bylaws of the corporation.

#### ARTICLE V – OFFICERS

## ARTICLE VIII – INDEMNIFICATION

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

## ARTICLE IX – TERM OF EXISTENCE

This corporation shall have perpetual existence and shall commence upon the filing of these Articles of Incorporation.
