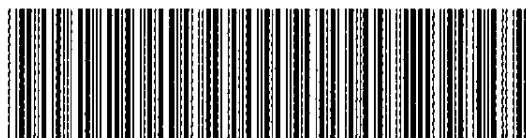

**ARTICLES OF INCORPORATION**  
**In Compliance with 617 F.S., (Not For Profit)**

the undersigned trustee subscriber to the Articles of Incorporation is a natural person competent to contract and has a valid United States of America passport, and is a citizen of the United States of America, and hereby forms a non profit Corporation pursuant to Florida Statutes Chapter 617.

**ARTICLE I- NAME**

The name of the corporation is: **LEGAL FORMS HEADQUARTERS CORPORATION, (hereinafter "Corporation")**.

**ARTICLE II- PRINCIPAL PLACE OF BUSINESS**

**ARTICLE VI-SPECIFIC PURPOSE**

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify

as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1954.

The corporation is a domestic violence shelter for women and provides a safe house and positive environment for them, while also providing valuable resources and services and transportation essential to their crisis and critical to the philosophy of the corporation. The corporation patterns naturalistic methods of intrinsic motivations to sustaining a confident and centered existence in the woman, predicated on the: social, emotional, intellectual, physical & spiritual attributes of the woman in this critical time. It is aimed by long standing studies of the President, who has dedicated most of her life to helping and supporting women in need, and recognizing that through efforts of the community resources and the Presidents' bachelor of science in education degree, that a informed and well educated cause can alleviate so much distress in the number one crime that kills women today! The President was a leader in grant recipient for building a facility aimed at mothers getting off of welfare and emerging into the workplace a confident adult, capable of coping and working and taking care of their young children, as well as the President received great acclamation for building the facility with the greatest fiscal management of any of the other facilities who received similar grant awards. The President emphasis's great attention to fiscal detail, which allows the projects to become role model facilities and successful because of this great attention. The President is an expert in formulating and forecasting social service issues that have a future impact on societal concerns. The President was a leader at hiring and being a part of disabled/physically handicapped workforce so they were able to become an integral part of society and was instrumental in formulating physically handicapped work place "friendliness rules" which made workplaces more at ease with hiring the physically challenged. component of the program is the corporation aids in picking up and receiving donated womens apparel, shoes, handbags, tools, hobby items, electronics, rugs and flooring items, wall hangings, software, food and consumables, household and furniture items and womens items and sewing items and clerical items aimed to enhance the domestic violence victims social confidence and encourages the community to donate business items and clothes whenever possible. They are also brought to church services in the area if they request that.

#### **ARTICLE VIII-TRUSTEES- MANNER TO BE ELECTED**

The Trustees shall have the power to admit and appoint trustees ,and/or officers, and/or directors of the corporation in such manner, subject to such qualifications, and upon such terms and with such rights as may be provided from time to time by By-Laws of the corporation,

#### **ARTICLE IX-TRUSTEE/CORPORATE POWERS**

The affairs of the corporation shall be managed by a Board of Trustees selected by the members themselves. The corporation shall hold and manage all property received and accepted by it to be administered hereunder, and shall pay over, transfer, merge, convert, relinquish, turnover, distribute, administer, or otherwise deal with the principal and income therefrom, in such manner or manners, and at such time or times, as in the judgment of the trustees shall be suited to carry out the foregoing language, the acquisition by purchase, gift rental, or otherwise and the management, care, sale or lease of other disposition of real property and interest in real property including buildings and other improvements thereon and contents therein, the construction, reconstruction, repair and/or alteration of such buildings and other improvements, the repair and/or alteration of such buildings and other improvements, the acquisition by purchase, gift, rental or otherwise, and the preparation, sale dispensation, lease, or other disposition of equipment, supplies, and other personal property and interest in personal property of whatsoever name or nature, and the retention of the services(whether directly or through contract or other arrangement with others), or employment of professional personnel, managers, administrator, assistants, secretaries, and other persons, agents, servants and employees. The trustees shall borrow money, and from time to time, to make, accept, endorse, execute, and issue bonds, debentures, promissory notes, bills of exchange, and other obligations of the corporation for moneys borrowed or in payment for property acquired or for any of the other purposes of the corporation, and to secure the payment of such obligations by mortgage, pledge, deed of trust, indenture, agreement, or other instrument of trust or by other privilege upon rights, or privileges of the corporation wherever situated, whether now owned or hereafter to be acquired. The Trustees shall invest and reinvest its funds in such stock, common or preferred bonds, debentures, mortgages or in such other securities and property as may be provided for in the bylaws of the corporation subject to the limitations and conditions contained in any bequest, devise, grant or gift, provided such limitations and conditions are not in conflict with the provisions of Section 501c3 of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended. It is intended in addition to convey all other corporate powers to this corporation are as provided in Section 617.0302, Florida Statutes.

#### **ARTICLE X- NON-PROFIT ITEMS**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to

its members, trustees, officers, or other private persons, except the payment of reasonable compensation for services rendered when deemed advisable by the board of trustees to carry out the purposes set forth in Article VI. This Corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence Legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (A) by a corporation exempt from federal income tax under section 501c3 of the Internal Revenue Code of 1954 or (B) by a corporation whose contributions are deductible under section 170C2 of the Internal Revenue Code of 1954.

#### **ARTICLE XI- DISSOLUTION**

Upon dissolution of the corporation, the board of trustees shall, after paying or making provisions for the payment of all of the liabilities of the Corporation, dispose of all of the assets of the corporation to another organization or organization which are organized and operated for the same purposes for which this corporation is organized, and with the identical likeness of building, including, but not limited to size and design and decorum and spacial representation of all areas and operated exclusively for charitable, educational, religious, literacy, and scientific purpose as shall at the time qualify as an exempt organization or organization under section 501c3 of the Internal Revenue Code of 1954, as the board of trustees shall determine. Any such assets not so disposed of shall be disposed of by the circuit court of the county in which the principal office is then located and/or other appropriate jurisdiction, exclusively for such purposes or to such organizations or organizations, as said court shall determine, which are organized and operated exclusively for such purpose.
