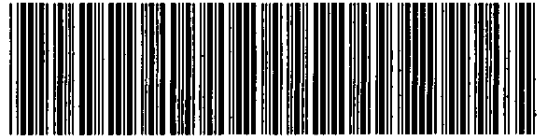

ARTICLES OF INCORPORATION
Incompliance with Chapter 617, F.S., (Not for Profit)

Article I Name

The name of the corporation shall be: Run for Third, INC.

Article II Principal Office

The principal place of business and mailing address of this corporation shall be: 325 Fern Lake Dr, Orlando FL.

Article III Purpose

The purposes for which the corporation is organized is:

A. The prime purpose of the corporation shall be to raise awareness on the impact of economical downfall of Third World Countries on its' families by promoting and encouraging walking and running.

B. In furtherance of objective "A." *this corporation may hold races on the road or track, lectures, fun runs, fundraising events, other educational activities, demonstrations, clinics, training programs, and social events; print and publish articles, and newsletters; make awards; and do all such other things as may be conducive to the encouragement of walking and running.*

C. Other objectives are to engage in community activities, to publicize by appropriate means the benefits of walking and running as means of physical fitness.

D. Said corporation is organized exclusively for the above purposes, and including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the correspondent section of any future federal code.

Article IV Dissolution

Upon dissolution of the corporation, the net assets of the corporation shall not inure to the benefit of any private shareholder, individual or corporation, but shall be distributed to one or more organizations operated exclusively for charitable, or other purposes as shall be at the time qualify as exempt organizations under Section 501(c)(3) of the internal Revenue Code, as determined by the Board.

The manner in which the directors are elected or appointed are as provided in the bylaws.
