# ARTICLES OF INCORPORATION OF KIDS TRIATHLON, INC. A Florida Corporation Not For Profit

SECRETARY OF STATE TALLAHASSEE, FLORIDA

In order to form a corporation in accordance with the provisions of the laws of the State of Florida for the formation of corporations not for profit, Chapter 617, Florida Statutes, the undersigned Incorporator, designates the following articles for the purposes and with the powers hereinafter mentioned.

#### ARTICLE 1

1.01. CORPORATION NAME. The name of this corporation is:

"Kids Triathlon, Inc."

#### **ARTICLE 2**

2.01. TERM OF EXISTENCE. The period of the duration of the existence of this corporation will be perpetual and shall commence at the time of filing of the Articles of Incorporation by the Department of State.

#### **ARTICLE 3**

- 3.01. PURPOSES AND RESTRICTIONS. The purposes of the corporation and restrictions on its operations are as follows:
- (a) The purposes for which the corporation is organized are exclusively charitable and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future United States Internal Revenue Laws (hereinafter the "Code").
- (b) The corporation shall restrict its operations to the promotion of charitable and educational purposes within the meaning of Section 501(c)(3) of the Code. Notwithstanding any

provision of these Articles of Incorporation to the contrary, the corporation shall take no action

inconsistent with the provisions of the Florida Not For Profit Corporation Act.

(c) No part of the net earnings of the corporation shall inure to the benefit of, or be

distributable to its members, directors, officers, or other private persons, except that the corporation

shall be authorized and empowered to pay reasonable compensation for services rendered and to

make payments and distributions in furtherance of the purposes set forth herein.

(d) The corporation shall also have the authority and power permitted under Florida

law to do any and all things and to exercise any and all powers, rights and privileges provided herein

and in the Bylaws consistent with its purposes and with the provisions of Section 501(c)(3) of the

Code.

**ARTICLE 4** 

4.01. NONSTOCK/NON-VOTING MEMBER CORPORATION. This corporation is

organized on a nonstock basis without the issuance of shares of stock evidencing ownership and

without voting members.

ARTICLE 5

5.01. REGISTERED AGENT AND PRINCIPAL OFFICE. The Registered Agent and the

6.01. DIRECTORS. The powers, business and affairs of the corporation shall be managed by and directed by the Board of Directors in accordance with these Articles and the Bylaws.
