

- 1. Article III, Section 3.04 of the Corporation's Articles of Incorporation is deleted in its entirety.
- 2. Article V, Section 5.01 of the Corporation's Articles of Incorporation is deleted in its entirety and the following substituted therefor:

Section 5.01. Annual Report. Consistent with Chapter 496, Florida Statutes, the Corporation shall provide the Miami-Dade County Mayor or his or her designee with an annual report that includes the following:
