The undersigned incorporator, for the purpose of forming a Florida Non-Profit Corporation pursuant to Florida Law, Section 617 hereby adopts and certifies the following Articles of Incorporation as follows:

ATICLE I NAME

The name of this Corporation shall be:

A La'CHANTE INTERNATIONAL CARE GIVERS, INC. and

the Corporation shall have perpetual duration.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 1852 NW 47TH Terrace; Miami, Florida 33142-4050.

ARTICLE III

PURPOSE

This Corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Non-profit Public Benefit Corporation Law and is organized exclusively for charitable, religious, educational and scientific purposes to aid the poor, disadvantaged individual, the physical and mentally challenge and families toward a life or self-sufficiency. For creating program for low income and at risk youth through awareness, preparation and including for such purposes, the making of distributions to organizations that quality as exempt organizations under section 501 © (3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law).

The specific purpose for which the corporation is formed is for the promotion of the good news of Salvation of Jesus Christ through the use of diverse ministries and the educational tutoring, including but not limited to the following:

A La'Chante International Care Givers Inc. is a spiritual base organization, in which students through the consent of their parent and or guardian's permission may attend Bible Study, Sunday School and Biblical training and seminars. It will also provide workshops for parents to assist them in parental involvement, spiritual development, and health care, also to provide conferences and conventions for self esteem, homework assistance and Biblical studying. The program will consists of reading, math skills and homework assistance, with volunteer tutors and future paid employees. A La'Chante International Care Givers Inc., will cover six dimensions of reading instructions during tutoring: they are phonemics awarness, phonic, fluency, vocabulary, text comprehension and motivation. The math skills building consist of learning to utilize manipulative, using real world

situations and problem-solving solutions.

Home learning (home work) assistance consists of explaining assignments, checking completed assignments.

The program will consist of but not limited to: Seminars, Outreach Advocacy for the Homeless and Disadvantaged, Health Care, Housing, Employment, Literacy, Counseling, Temporary and Permanent Shelter for the Physical and Mentally Challenge, Aides Patients and Patients with Diabetes and other in need of Shelter, Diabetes Awareness, Teenage Pregnancy, Teenage Abstentious, Job Training, Job Placement and Acquisition, Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elderly Care, Entertainment and Social Services, Housing For The Elderly, Referrals for Youth, Adults and The Elderly, and all other programs to aid the Youth, Adults and The Elderly and to aid in need.

Specifically, the purpose of the organization shall be to further the positive growth and educational development of children and individuals with a history of social problems. This corporation shall provide instruction and training in social and educational skills that will enable children, youth and other individuals to improve their capabilities on subjects programs and other related activities; individuals will be able to become productive members of society.

Television and Radio Ministries, publication of tracts and literature; to purchase, sell and otherwise deal in real and personal property; the building of churches and Christian schools both within and outside the United States; to conduct and promote various Ministries and Christian Schools set forth above. The organization is to start other ministries and Christian Schools and organize other churches under said ministry and Christian School to license and ordain all such ministries and teachers.

Generally, the purpose shall be to have and exercise all rights and power to conferred upon non-profit corporations under the laws of Florida, including the power to contact, rent, buy and sell personal or real property, provided, however, that this organization shall not except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

The foregoing purpose and activities will be interpreted as examples only and not as limitations and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purpose, which may become necessary profitable, or desirable for furtherance of the corporation objectives expressed above. Notwithstanding any of the above statements of purposes and powers this corporation shall engage in activities that in themselves are furtherance of the purpose set forth in Article III and for such charitable purposes as are within the meaning of and for all other Lawful purpose for which non-profit corporation may be formed under Section 510 © (3) of the Internal Revenue Code of 1986.

A La'Chante International Care Givers, Inc. will provide the same services; it will be use for Vocational Bible School. It will have summer activities, field trips, Bible Studies, Tutorial Services and other activities. It will also operate doing Spring and Winter Break.

ARTICLE IV

MANNER OF ELECTION

The manner in which the directors are elected or appointed: They must be spirit filled and dedicated to be appointed. They will be elected or appointed accordingly as stated in the BYLAWS of A La'Chante

International Care Givers Inc.

ARTICLE V

DISTRIBUTION

No part of the net earnings of the Corporation shall insure to the benefit of or be distribute to its members, trustee, officers or private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purpose set forth in Article II hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda or otherwise attending to influence legislative and the corporation shall not participate in or intervene is (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 (or Corresponding provision of any future United States Internal Revenue Code) or (b) by a corporation to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law).

ARTICLE VI

EXISTENCE

The Corporation shall perpetual existence.

ARTICLE VII

QUALIFICATION OF MEMBERS

Membership shall be freely admitted to the Corporation, those who are willing to promote the purpose of this corporation. The qualification of members shall be set by the by-laws of the corporation. Men, Women, boys and girls will be freely accepted to the membership.

ARTICLE VIII

MANAGEMENT
