Article I

The name of the Corporation shall be The Bunny Platoon of Vietnam, Inc..

Article II

The principle place of business and mailing address is 1517 Hillcrest Street, Orlando, FL 32803.

Article III

Said corporation is organized exclusively for charitable purposes of providing services, at no cost to our members, other combat veterans and families of those killed in action or deceased after military service: To bring together sources to help combat veterans deal with life as a returning veteran. We will introduce them to governmental sources to help with their dealings with Veteran's Administration in filing claims, appeals and making them aware of all services available. Provide a network of fellow combat veterans to meet and discuss their experiences and any issues that may trouble them. And the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV

This corporation is to exist perpetually, unless sooner dissolved according to law. If dissolved all assets shall be given to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article V

The Board of Directors shall be elected by the members of the organization which served as the 3rd platoon of Bravo Company, 5th/60th infantry regiment, 9th Infantry Division and/or 3rd platoon of Bravo Company, 1st/16th infantry regiment, 1st Infantry Division from the period February 1968 through June 1969 (The Bunny Platoon), or family of those killed in action or deceased after service.



No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
