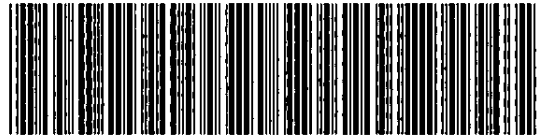

The undersigned, acting as incorporators of the corporation under The Florida general corporation Act, adopt the following articles of Incorporation for such corporation.

ARTICLE I NAME
