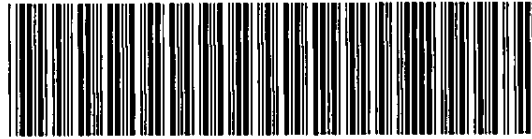



Attachment A

Article III PURPOSE

The corporation is organized exclusively for educational and scientific purposes, under 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax code.

No substantial part of the corporation's purposes shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, nor intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the assets or net earnings of the corporation shall inure to the benefit of, or be distributable to, its incorporators, members, directors, officers, or other private persons having a personal or private interest in the corporation, except that American Green Lodging and Hospitality Association shall be authorized and empowered to pay reasonable and customary compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article.
