This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is To access grants and funding to be used for the purpose of providing not for profit programs and services associated with driver education and safety, including reduced and free registrations for driver's education, on the road instruction, driver safety training, drug/alcohol and drivers training programs to support reinstatement of suspended or revoked driver's licenses.
