ARTICLES OF INCORPORATION
of

The undersigned hereby establishes the following for the purpose of becoming a Not for Profit Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for:
TEACHING AVERY RESOURCE AND EDUCATION FOUNDATION, INC.

ARTICLE I
The name of the corporation shall be
TEACHING AVERY RESOURCE AND EDUCATION FOUNDATION, INC.

ARTICLE II

ARTICLE III
This Corporation is organized for the following purposes:
To have and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon corporations organized pursuant to the laws under which the Corporations is organized and any and all amendatory thereof and supplemental thereto.

For the purpose of transacting any or all lawful business
To do any and everything pertinent to the above
To conduct seminars, workshops youth financial planning and career development
To conduct after school and summer programs and activities for youth
To conduct cultural, music and education classes, programs and activities
To provide community and family service projects
To conduct seminars for families of children with disabilities and their siblings

Act in any other fashion and engage in other activities and functions that are proper and further the goals and purposes of the corporation.

No part of the activities of the corporation shall be the carrying on or propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including publishing or distribution of statements) any political campaign on behalf or any candidate for public office.

Notwithstanding any provisions of these articles, the corporation shall not carry any other activities not permitted to be carried by the corporation exempt from federal income tax under section 501c3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

To have and exercise all the powers necessary or convenient to effect the objects for which it is formed, and in general to have and exercise all powers conferred by the State of Florida upon corporation created under Florida's law as they may now be or are hereafter amended. The foregoing enumeration of the objects purposes and powers of the corporation is not intended to and does not prohibit or limit the exercise of any other or further rights or powers which may now or hereafter be allowed or permitted by law to the corporation, provided, however, that all gifts and bequests to the corporation and the net earnings and assets of the corporation shall be used only in the United States of America exclusively for the purpose for which it is formed.

**ARTICLE VIII
DISSOLUTION OF THE CORPORATION**

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

In the event of dissolution, the residual assets of the Corporation will be disposed according to state laws and 501c3 corporation laws.

The Corporation shall observe and obey a conflict of interest policy that shall be regulated by the Corporation By-Laws.


