ARTICLES OF INCORPORATION OF
MUJERES EN CLAMOR INC.

ARTICLE I NAME

The name of this corporation is MUJERES EN CLAMOR INC.

ARTICLE II DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III PURPOSE

1- This corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Service Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue Law. Specifically, but not limited, this corporation will be involved in preaching the gospel, helping the community in family relations, helping the woman in distress, helping children from dysfunctional families, and promoting good relationships.

2- In addition we will provide for those in need of restoration and mercies, the preaching and dissemination of the gospel of Jesus Christ and the word of God, through churches, schools, woman center, shelters, prison, adult care centers, hospitals, and other ministries.

3- We also will Foster and promote in the areas of economic well-being, social relationships, intellectuals achievements, physical improvement and spiritual development and growth for the purpose of enabling mankind of all ages and races, regardless of the status of each individual, to form a more realistic attitude and approach to God as the Father and creator of all things and the continues improvement in the relationships of human being among themselves.

4- To support and encourage communication and extension of the Christian life and witness by sound and comprehensive preaching and teaching of the Holy Bible of the Lord Jesus Christ to all men, both within this fellowship and elsewhere, not only by conventional modes, but also by means which will accomplish such communication, extension, teaching and preaching including, but not limited to media of communication development by modern technology but not for private profit, to sponsor or participate in conduct or engage in radio broadcasting, television broadcasting, the printing or reproduction or publication of recording, books and others materials; the establishments and operations of seminars, study groups, work shops, and meetings with evangelists, pastors, teachers and other elders; to receive offerings for such purposes; and to grant aid and pay reasonable compensation for services

actually rendered to persons, firms and corporations for such purpose.

5- To provide social services and establish program of assistance to the elderly, to visit jails and hospitals and provide the physical, emotional and spiritual support needed.

ARTICLE IV CAPITAL STOCK

This corporation shall issue no stock.

ARTICLE V LOCATION

The Street, Address, City, County and State in which the principal offices of the corporation are to be located are, 6200 SW 122 Avenue, Miami, Florida 33183. The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.

ARTICLE VI INITIAL BOARD OF DIRECTORS

ARTICLE VIII AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, and approved by the majority of the members at a General Assembly meeting, unless all the Directors sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation is made.

ARTICLE IX LIMITATIONS

1. No part of the net earnings of this corporation shall inure to the benefit of or be distributed to its directors, officers or other private person except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article.

2. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements.

3. No withstanding any other activities not permitted to be carried on by a corporation exempt from federal income tax under §501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law, or by a corporation, contributions to which are deductible under §170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE X DISSOLUTION

On the dissolution of this corporation, the board of directors shall dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner of the organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes and that shall at the time qualify as exempt organizations under §501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purpose or to the organizations that the court determines are organized and operate exclusively for charitable, educational, religious or scientific purposes.
