

# CERTIFICATE OF REINCORPORATION FOR MIAMI BEACH ROD & REEL CLUB, INC.

We, the subscribers hereto, hereby associate ourselves together for the purpose of forming a rod and reel club, and/or society or association, which said club shall be a corporation not for profit; by and under the provisions of Section 617.0901, Florida Statutes, this certificate of reincorporation was duly authorized by a meeting of its members regularly called or by a meeting of its board of directors if there were no members entitled to vote on the reincorporation.

#### ARTICLE I.

The name of this corporation shall be MIAMI BEACH ROD & REEL CLUB, INC.

#### ARTICLE II.
