ONE: The name and address of this principal corporation is God's Helping Hand for, Women and Children Resource and Living Facility, Inc. at 914 garden Street, Kissimmee, FL 34744, in Osceola County. The Corporation is organized pursuant to the FLORIDA Non-profit Corporation Code.

TWO: This Corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The Corporation is organized under the Non-profit Public Benefit Corporation Law for charitable and educational purposes to aid the community with programs that consist of: Daycare, Employment, Transitional Housing, Counseling, Parenting skills classes, Women Support Group and other issues to assist battered and abused women.

THREE: The duration of this Corporation shall be perpetual, with no stock and shall have no members.

SEVEN: The property of this Corporation is irrevocably dedicated to Charitable and Education purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

EIGHT: On the dissolution or winding up of the Corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this Corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for, Education and Charitable under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.
