

ARTICLE I The name and address of this corporation is Let Go And Let God Ministries Inc., 816 Sharron Circle Lakeland, FL. 33815 Polk County. The corporation is organized pursuant to the **FLORIDA** Nonprofit Corporation Code.

ARTICLE II This corporation is a Nonprofit Ecclesiastical and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Religious benefit Corporation Law for religious, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consists of, but shall be limited to: Job Training, Job Placement, land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Family Planning, Monitoring, Substance Abuse and Awareness, and AIDS Awareness programs to aid those in need.

ARTICLE III The duration of this corporation shall be perpetual, no stock and shall have no members.
