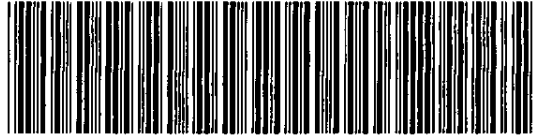

**ARTICLES OF INCORPORATION  
A Florida Non-Profit Organization**

The Undersigned, majorities of whom are citizens of the United States, desiring to form a Non-Profit Incorporation pursuant to Chapter 619 of the Florida Statutes under the Non-Profit Corporation Laws of the State of Florida, do hereby certify:

**ARTICLE I - NAME OF INCORPORATION:** Higher Power Miracle of Faith Non-Dominational Church, Inc.

The name of the Incorporation shall be as follows: Higher Power Miracle of Faith Non-Dominational Church, Inc.

**ARTICLE II - LOCATION OF PRINCIPAL OFFICE:**

The address in this state where the principal office of the Incorporation shall be located 3930 North Orange Blossom Trail, Orlando, Orange County, Florida 32804-2705, and any office within the State of Florida as amended in accordance of the State of Florida Department of Corporation by filing Amendment to this Article of Incorporation.

**ARTICLE III - PURPOSE**

This Incorporation, Higher Power Miracle of Faith Church, Inc. is a Non-Profit Religious Benefit Corporation organized and operated exclusively for Religious, Charitable, Benevolent and Educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Our general purpose and object of the Incorporation shall be for Religious Ministries and to instruct, to conduct, to educate and to offer benevolent services to our members and individuals which would be guided concerning the Article of Faith and the Creed which is the revelation of one Lord, one Faith and one Baptism and to impart spiritual enlightenment to advance spiritual growth, moral and personal purity and evangelism amongst it members and the people of the community.

To aid in the spreading of the gospel to the ends of the earth which would educate, prepare, and ordain men and women for the ministry in the Church. This Incorporation is organized under the Non-Profit Laws pursuant to Chapter 619 of the Florida Statutes, which is organized exclusively Religion, Charitable, Benevolence and Educational Purposes.

**ARTICLE IV - ARTICLE OF FAITH/ Creed:** We the Officers and Members of Higher Power Miracle of Faith Church Non-Dominational Church, Inc. believe in The Father, The Son and The Holy Ghost as the Trinity. "Jesus saith unto him. I am the way, the truth, and the life: no man cometh unto the Father, but by me. If ye had known me, ye should have known my Father also: and from henceforth ye know him and have seen him." John 14:6-7.

"Believest thou not that I am in the Father, and the Father in me? The words that I speak unto you I speak not of myself; but the Father that dwelleth in me, he doeth the works." Believe me that I am in the Father, and the Father in me; or else believe me for the very sake. Verily, verily, I say unto you, He that believeth on me, the works that I do shall he do also; and greater works than these shall he do; because I go unto my Father. And whatsoever ye shall ask in my name, that will I do, that the Father may be glorified in the Son. If ye shall ask any thing in my name, I will do it. If ye love me keep my commandments. And I will pray the Father, and he shall give you another Comforter, that he may abide with you for ever; Even the Spirit of truth; whom the world cannot receive, because it seeth him not, neither knoweth him; but ye know him; for he dwelleth with you and shall be with you. I will not leave you comfortless: I will come to you." John 14:10-18.

## **ARTICLE VIII – ELECTION OF BOARD OF DIRECTORS:**

There shall be at least Three (3) and not more than Seven (7) members of the Board of Directors. The existing Board of Directors is the Founding Members of this body. The election of additional/or dismissal of any member or members to the Board of Directors prior to the first (1<sup>st</sup>) year of the standing BOD may elect to add additional member(s) to the Board of Directors by election of the Chairman of the Board if it is in the best interest of the Board.

## **ARTICLE IX – CHANGE IN NUMBER OF BOARD OF DIRECTORS:**

A change in the number of Board of Directors of this Incorporation shall be made only by Amendment to these Articles of Incorporation and as stated in the By-Laws. However, if in an event a Board Member resigns voluntary, expires or is dismissed by the Chairman of the Board or 2/3 quorum after to the First (1<sup>st</sup>) year Annual Board Meeting. The presiding Board of Directors may elect or appoint a member(s) to preside in such position temporary and hold such position until election time as indicated.

## **ARTICLE X - NO BENEFIT TO PRIVATE PERSONS OR POLITICAL ACTIVITY**

No part of the net earnings of the Incorporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers, or other private persons, except that the Incorporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Organization shall not carry on any other activities not permitted to be carried on (a) by this Non-Profit Organization which is in accordance with the corresponding section of any future federal tax code. "Notwithstanding any other provision of

these Articles of Incorporation, this Organization shall not, except to an insubstantial degree engage in an activities or exercise any powers that are not in furtherance of the purposes of this Organization or by a Corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.”

#### **ARTICLE XI – Internal Affairs**

The Internal Affairs of this Church Incorporation shall be governed in accordance with the By-laws of this Organization. It is hereby noted this Non-Profit organization can receive gifts by bequest from Last Will and Testaments, from Individuals, Businesses and For-Profit Corporations, Donations, Tithing, and Offering from members and organizations originated within or out the Church which will benefit the requirements of the Church’s operations.

#### **ARTICLE XII - NOTICE OF NONDISCRIMINATORY POLICY**

This Non-Profit Incorporation, Higher Power Miracle of Faith Non-Dominational Church, Inc. does not discriminate against any race, color, creed, disabilities, nationality, and ethnic origin. Our Church doors are open to all individuals who believe in the Father, the Son, and the Holy Ghost and the Church’s Creed, which are incorporated in this Non-Profit Incorporation also incorporated within the Church’s By-laws accordingly. We allow all the rights, privileges, programs, and activities generally accorded or made available to participants within our Church’s family.

#### **ARTICLE XII – DISSOLUTION OF CORPORATION**

Upon the dissolution of the Non-Profit Incorporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this Non-Profit Incorporation shall be distributed for one or more purposes within the meaning of the Internal Revenue Code or shall be distributed to the designated successor exclusively for the purposes of which this Non-Profit Incorporation was organized in accordance with of the Internal Revenue Code or the corresponding section of any future federal tax code.


