Article III

Return of Yeshua Ministries Inc- The purposes for which this corporation is formed are exclusively charitable, educational and religious consisting of the following: To aid, support, and assist by gifts, contributions, or otherwise, other corporations, community chests, funds and foundations organized and operated exclusively for charitable or educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies, **Our focus** through programs which include, but which will not limited to is grooming the people for Christ return, encouraging the body of Christ to stay within their first love, rebuild the image of the Holy Spirit's character, to rekindle the fire of God by ministering to those in the body of Christ who are destine for hell and do not know it. We will prepare believers to live in eternity, redefine godly morals and principles. Provide housing for traveling ministers.

Return of Yeshua Ministries Inc will also focus on charitable purposes such as empowering individuals towards self sufficiency. By providing a shelter for battered women and abused family members, provide services to immigrants, food and clothing distribution, counseling for alcohol abuse, and empowering battered women and children. Assist men with parental visitation rights, assistance and or counseling for men and women going through a divorce. Provide self defense training and career training.

Article IV

Lobbying and Political Campaigns: No part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

Article V

DISSOLUTION: Upon winding up and dissolution of the Corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986 to be used exclusively for charitable and educational purposes. If the Corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by decree of the Circuit Court of the district in which the Corporation's principal office is located, upon petition thereof by the Attorney General or by any person concerned in the liquidation.

Article VI

Any vacancy in the Board of Directors, including one created by an increase in the number of Directors, may be filled for the unexpired term by a majority vote of the remaining Directors, even if less than a quorum.




