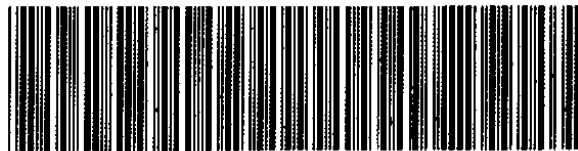

The purpose for which the corporation is organized is:

The Purpose for which the corporation is organized exclusively religious within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Revenue law governing religious/ tax exempt organizations. Notwithstanding and other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law governing religious/tax exempt organizations. The corporation will carry out this purpose by providing a community based support system through the church atmosphere which will provide financial support for programs through gifts, donations, contributions, and grants. The period of the duration of this corporation is perpetual unless dissolved according to law. Subject to the limitations applicable to Section 501(c)(3) organization, the corporation shall have the general powers set forth in Section 617.0302, Florida.




