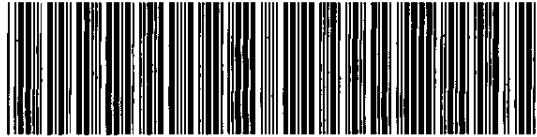

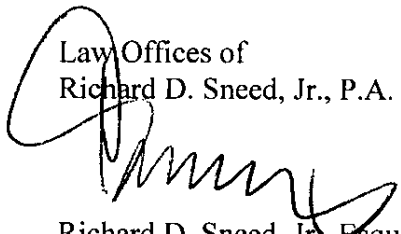

ARTICLES OF INCORPORATION

FOR

THE RABURN FOUNDATION, INC.

(A Florida Not for Profit Corporation In compliance with Chapter 617, F.S.)

ARTICLE I - NAME

The name of the corporation shall be the RAYBURN FOUNDATION, INC.

ARTICLE II - ADDRESS

The principal street address and mailing address, is:

1806 South 33rd Street, Ft. Pierce, FL 34947.

ARTICLE III - PURPOSE

The corporation is a corporation not for profit corporation organized pursuant to the Florida Not for Profit Corporation Act set forth in Chapter 617 of the Florida Statutes. The period of duration of the corporation is perpetual unless dissolved according to law.

The corporation is organized exclusively as a funding source for future dental and/or medical missions to Nicaragua, capital improvement projects designed to improve the lives of individuals residing in this country, and any other business allowed under Florida law.

ARTICLE VI - MANNER OF ELECTION

A board of directors must consist of three or more individuals, with the number specified in or fixed in accordance with the articles of incorporation. The number of directors may be increased or decreased from time to time by amendment to, or in the manner provided in, the articles of incorporation or the bylaws, but the corporation must never have fewer than three directors. The directors shall be elected or appointed in the manner and for the terms provided in the articles of incorporation or the bylaws by a two-thirds quorum of the members of the corporation.

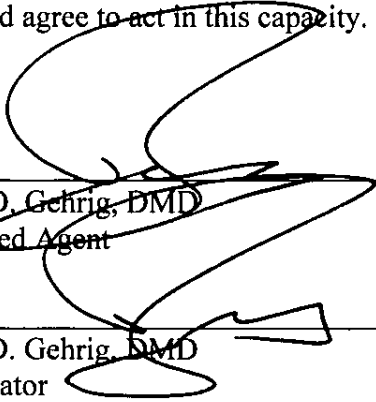

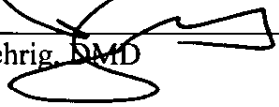
