ARTICLES OF INCORPORATION OF MINISTERIOS GRACIA Y AMOR, INC.

The undersigned, for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1: NAME

The name of the corporation is Ministerios Gracia y Amor, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal office is 509 Citroen Drive, Sebring, Florida 3387

ARTICLE III: PURPOSE

Said corporation is organized exclusively for providing benevolent, outreach, ministerial, charitable, religious and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV: DIRECTORS/OFFICERS

The corporation shall initially have four (4) Directors. At no time shall the number of Directors be less than three (3). The corporation shall have a President, Treasurer and Secretary. Directors and Officers shall be elected or appointed annually by the then serving Board of Directors. Appointment or election shall be by majority vote of the Board.

ARTICLE V: INITIAL DIRECTORS

ARTICLE VI: INITIAL REGISTERED AGENT

ARTICLE VII: INCORPORATOR

ARTICLE VIII: NO PRIVATE INUREMENT / PROHIBITED ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


ARTICLE IX: DISSOLUTION


