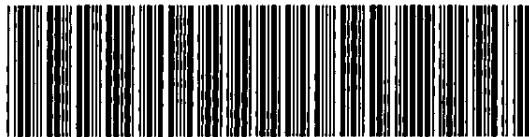

**Articles of Incorporation
of
Faith Family Community Church, Inc.**

The following non-profit Corporation is being organized by the following Florida resident pursuant to Chapter 617.0202, F.S. of the Florida Statutes.

**ARTICLE I
Name of Corporation**

The name of the Florida non-profit Corporation shall be Faith Family Community Church, Incorporated. The Corporation shall be a non-member corporation.

**ARTICLE II
Place of Business and Mailing Address**

The Corporations principal place of business is 2914 Lithia Pinecrest Road, Valrico, FL 33594. The mailing address is 1407 W. Pradera Avenue, Tampa Florida 33612.

**ARTICLE III
Purpose of Corporation**

The purpose of this corporation is to worship God, preach the Gospel, celebrate communion, sponsor community (fellowship) and unity among all, offer spiritual growth, and render loving service by living out the Great Commandment of Jesus to love God with all our hearts, all our souls and all our minds and to love our neighbors as ourselves.

**ARTICLE IV
Appointment/Election of Director**

The Board of Directors/Council shall be appointed initially by the pastor, Rev. Dr. Katherine Rooke, and approved by the congregation at a congregational meeting and will serve in that capacity for a period not to exceed twelve months. The existing Board of Directors, on an annual basis, will ask the congregation for candidates of qualified individuals to be considered for these positions, offices and function as is deemed necessary to conduct the business of the Corporation. The congregation will elect and install such candidates to their elected office by a majority vote. There shall be no prohibition of an existing officer and/or board member exceeding him or herself and serving the Corporation at the pleasure of the corporation.

ARTICLE V

Registered Agent/Address

ARTICLE VII
Name/Address of Incorporator

Rev. Dr. Katherine Rooke shall be the incorporator of the Corporation and her address is 1407 W. Pradera Avenue, Tampa, FL 33612

ARTICLE VIII
Dissolution of Corporation

At such time as the Board of Directors elect to dissolve the Corporation, as is in compliance with the Bylaws of the Corporation, all outstanding debts and financial obligations of the Corporation shall be paid in full from the proceeds of the Corporation and any assets remaining of the Corporation shall be given, transferred, deeded to and/or conveyed in full to St. Mark United Church of Christ, located at 2914 Lithia Pinecrest

Road, Valrico, FL 33594, a non-profit Corporation in good standing with regulations governing non-profit corporations.

ARTICLE IX **Non Discrimination Policy**

The Corporation shall not in any manner discriminate against any individual(s), person (s) or groups of people (s) for any reason as stated in current Federal Statues, State of Florida Statues, or because of a persons race, creed, sex, national origin, sexual orientation or gender identity/identification. Therefore, all individual(s), person(s) or groups of people(s) shall have full and complete access to all the programs and benefits of the Corporation and shall be, with appropriate qualification(s), credential(s) and/or certification (s) to perform such job vacancy and considered for full employment in the Corporation.

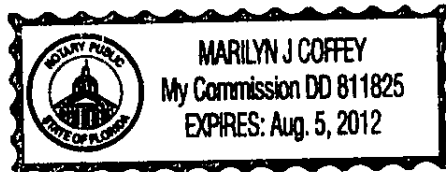
