

# ARTICLE OF AMENDMENT TO THE ARTICLES OF INCORPORATION

**OF** 

#### L.I.N.K.S. FOUNDATIONS INC.

The Article of Amendment of the Article of Incorporation of L.I.N.K.S. FOUNDATIONS INC., (the corporation), a Florida Nonprofit, are hereby executed in duplicate by the corporation as follows:

Article III shall be amended as follows:

#### **ARTICLE III**

#### **PURPOSE**

This not for profit is organized exclusively for charitable purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1996 or the successor provision of any future United States Internal Revenue Law. The purpose of the association shall be to inspire and empower young people to be leaders, friends, and servants to their communities.

This will be achieved through mobilizing youths of every race and colors towards achieving this objective. Donations from individuals, institutions and governmental institutions will be devoted towards the organization's objectives.

To the end that the forgoing objectives and purposes and any related religious and charitable purposes may be carried out, performed and accomplished, this corporation shall have the power to engage only in such activities as shall not constitute business related to its charitable and educational purposes. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c)(3) of the Internal Revenue Code of 1996 or the successor provision of any future United States Internal Revenue Law. Subject to the foregoing limitations, this corporation shall have all of the rights and powers set forth in Section 617,0302.

#### The following Article shall be added:

# ARTICLE IX DURATION

This corporation shall exist perpetually. Corporate existence shall commence on the date the first Article of Incorporation was filed.

### ARTICLE X DISTRIBUTION

No part of the net earnings of the non-profit shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the non-profit shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause thereof. No substantial part of the activities of the organization shall be for carrying on of propaganda, or otherwise attempting to influence legislation, and the non-profit shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any activities not permitted to be carried on (a) by a nonprofit organization exempt from federal income taxes under Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

# ARTICLE XI DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
