

**ARTICLES OF INCORPORATION
OF**

SOUTHERN HOT ROD ASSOCIATION, INC.

The undersigned, desiring to form a Corporation Not For Profit for the purposes hereinafter stated, under and pursuant to Chapter 617 of the Florida Statutes, do hereby declare as follows:

I. NAME

The name of the Corporation shall be **SOUTHERN HOT ROD ASSOCIATION, INC.**

II. NOT FOR PROFIT PURPOSE

The Corporation is being organized for the purpose of promoting, assisting and marketing Hot Rod activities, including conducting races at legal and proper forums throughout the State of Florida and the United States and representing the interest of the members of the associations and such other permitted purposes. In furtherance of its corporate purpose, the Corporation shall have all general powers enumerated in Section 617.0302 of Florida Statutes, being the Not For Profit Corporation Law, as same may be amended.

III. PRINCIPAL OFFICE

The principal office and mailing address of the Corporation shall be located at 6499 North Powerline Road, Suite 106, Fort Lauderdale, Florida 33309.

IV. BOARD OF DIRECTORS

The affairs of the Corporation shall be conducted by a Board, of not less than two (2) or as may be modified in accordance with the terms and conditions of the By-Laws of the Corporation. The manner in which the members of the Board of Directors shall be elected shall be as provided for in the By-Laws of the Corporation.

V. INITIAL OFFICERS


