ARTICLE ONE - NAME

The name of this Not-For-Profit Corporation is: Community Reaching Youth, Inc.

ARTICLE TWO - ADDRESS

ARTICLE FOUR - 501C3 LANGUAGE

The purpose of this Corporation is that of a Charitable Organization that will provide Community Outreach Services at an international level including but not limited to: This Corporation is specifically designated as a community outreach program helping young me between the ages of 13-25 to get back on track through training programs, GED Classes and drop out and gang Prevention. "An organization's articles state that it's purpose is to receive contributions and pay them over to organizations that are described in Section 501C3 and exempt from taxation under Section 501a.
