**Article VIII**

This Corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding section of any future United States internal revenue law).

No substantial part of the activities of this Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this Corporation shall not participate in or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation, and the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding section of any future United States internal revenue law).

**Article IX**

The property of this Corporation is irrevocably dedicated to religious purposes and no part of the net earnings or assets of this Corporation shall ever inure to the benefit of, or be distributable to any director or officer thereof or any individual, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered, or to make payments and distributions in furtherance of the purposes set forth in Article III above.

On the winding up and dissolution of this Corporation, after paying or adequately providing for the debts and obligations of the Corporation, the remaining assets of this Corporation shall be distributed to an organization (or organizations) that is (are) organized and operated exclusively for religious purposes and that is (are) tax exempt under Section 501(c)(3) of the Internal Revenue code of 1986 (or the corresponding section of any future United States internal revenue law).
