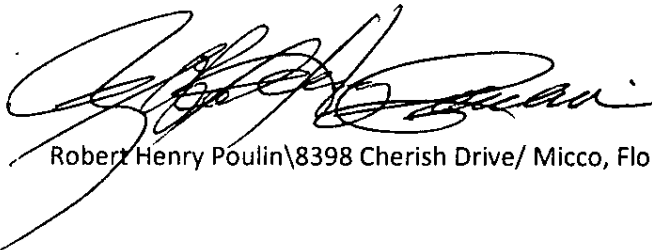

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To assist the needy of the world, as best the Charity can identify, and assist within the scope of their funding, to assist in areas of health, and human needs, to include feeding and assisting other not-for-profit organizations in their stated goals and plans. This plan intends to assist other families, or persons to form nonprofits, whereby a percentage of their earnings can be placed in the nonprofit, and to explore other legal means to receive donations to assist in these stated goals. This is a world organization intended to help others where we identify a sincere needy need. The plans and policy of the disbursements shall be directed by the Board and must be approved by said Board before and prior to disbursement. The organization is organized and operated exclusively to assist the needy of the world, and any, and all appropriate means, through donations, and to include lectures, seminars, study groups, public and classroom performances, exhibits and all other appropriate means. The Executive Vice President of the organization will specifically be directed to perform educational as herein directed, or otherwise appointed by said person a representative to perform such functions as is deemed appropriate to the said stated goals as herein purposed, and regulated within the meaning of 501 (c) (3) of the Internal Revenue code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The nonmembership structure shall consist of not less than three Board members, and the method of election to the Board shall be by appointment by the Chairperson of the Board and every member shall serve at the will and pleasure of the Chairperson, and any Board member may be discharged from responsibility by the Chairperson with or without cause. No Board member shall be paid for services whatsoever services are performed by said person(s)

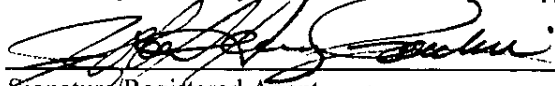

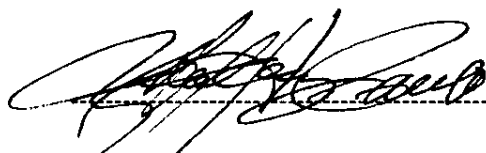

In witness thereof, I, Robert Henry Poulin, the undersigned incorporator did execute these articles of incorporation on this 9 day of November, 2009

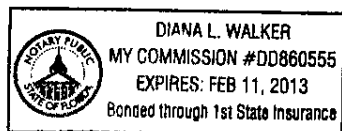
