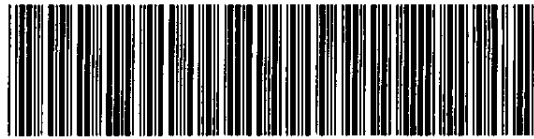

**ARTICLES OF INCORPORATION
OF
SOUL SAVING STATION WOMEN'S SHELTER, INC.**

ARTICLE I - NAME

The name of the non-profit organization shall be:

SOUL SAVING STATION WOMEN'S SHELTER, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III - PURPOSE

This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Non-Profit Public Benefit Corporation Law, for charitable and educational purposes to aid battered and abused women towards a life of self-sufficiency. The programs will consist of but not be limited to: Seminars, Outreach Advocacy for the Homeless and Disadvantaged, Health Care, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Job Training, Job Placement and Acquisition, Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elderly Care and other programs to aid those in need.

- (a) This organization is further organized and operated to provide temporary shelter as well as permanent housing for battered and abuse women. The organization will also endeavor to inform and advise women about the importance of an adequate education in their quest for independence. We will further seek to provide other charitable activities within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
- (b) Notwithstanding any other provisions of these articles the corporation shall not carry on any other activity not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code or (2) by a corporation contribution to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

ARTICLE V – MANNER OF ELECTION

The Executive Director of the Corporation shall be an ex-officio member of the Board with voting privileges.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for Religious, Charitable and Educational purposes under Section 501 (c) (3) of the internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
