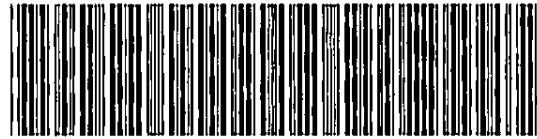

**AMENDED AND RESTATED
ARTICLES OF INCORPORATION**

OF

**THE FLORIDA RECYCLING PARTNERSHIP, INC.
a Florida not-for-profit corporation**

The corporation, formed under the Florida Not-for-Profit Corporation Act, does hereby amend and restate its Articles of Incorporation as follows:

ARTICLE ONE

NAME

The name of the Corporation is THE FLORIDA RECYCLING PARTNERSHIP, INC.

ARTICLE TWO

PRINCIPAL OFFICE

The address of the principal office and mailing address of the Corporation is 730 East Park Avenue, Tallahassee, Florida 32301

ARTICLE THREE

PURPOSE

- A. The purpose for which the Corporation is organized is to educate the public about recycling in the State of Florida.
- B. The Corporation is organized exclusively for purposes permitted under section 501(c)(3) of the Internal Revenue Code.

- C. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- D. Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE FOUR

DIRECTORS

At all times there shall be not less than three (3) directors of the Corporation. The number of directors in excess of three (3) and method of their election is set forth in the Bylaws.

ARTICLE FIVE

MEMBERS

The Corporation will have members. The Bylaws of the Corporation contain provisions relating to qualifications for membership, the rights of members, and other such matters.

ARTICLE SIX

REGISTERED AGENT AND ADDRESS

As set forth in the registered agent's written acceptance of appointment, which is delivered to the Department of State together with these Articles of Incorporation, the name and address of the initial registered agent for the Corporation is Keyna Cory, 730 East Park Avenue, Tallahassee, Florida 32301

These Amended and Restated Articles of Incorporation were approved by the Board of Directors.

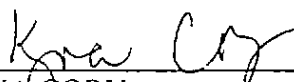
