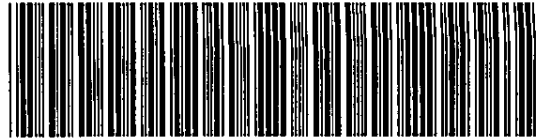


Subject: Letter of resignation as a Director and Board member of BASA Aeronautical School, Inc. (BASA)


