ARTICLES OF INCORPORATION OF SECRET PH 3:09 INDIAN RIVER TEA PARTY, INC.

We, the Incorporators, being natural persons of the age of twenty-one year of more and citizens of the United States, for the purpose of forming a corporation under the provisions of Chapter 617 of the Florida Statutes, do hereby adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of this corporation shall be Indian River Tea Party, Inc. and it shall be referred to herein as the "Corporation."

ARTICLE II Purposes and Limitations

The Corporation is organized as a not for profit corporation pursuant to the provisions of Chapter 617 of the Florida Statutes with the following purposes and limitations:
