**ARTICLES OF INCORPORATION OF
INDIAN RIVER TEA PARTY, INC.**

We, the Incorporators, being natural persons of the age of twenty-one years or more and citizens of the United States, for the purpose of forming a corporation under the provisions of Chapter 617 of the Florida Statutes, do hereby adopt the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of this corporation shall be Indian River Tea Party, Inc. and it shall be referred to herein as the "Corporation."

**ARTICLE II
Purposes and Limitations**

The Corporation is organized as a not for profit corporation pursuant to the provisions of Chapter 617 of the Florida Statutes with the following purposes and limitations:

The purpose of the Corporation is to promote the principles of limited government, fiscal and individual responsibility and the free market system through education and grass roots civic activity.

**ARTICLE III
Directors and Election of Directors**

The authority for all affairs of the Corporation shall be in a Board of Directors who shall have and may exercise all the powers of the Corporation as permitted by federal law, state law, these Articles of Incorporation, and the Bylaws of the Corporation as from time to time in effect. The Board of Directors will be elected under a method to be stated in the bylaws of the Corporation.

ARTICLE IV

Incorporation of Definition of Terms

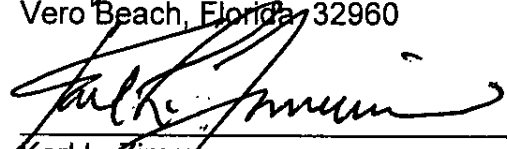
